#### East of England Strategic Review of the Mount Vernon Cancer Centre

NHS England East of England Specialised Commissioning Team and NHS London are undertaking a review of the Mount Vernon Cancer Centre (run by East and North Hertfordshire NHS Trust at the Hillingdon Trust in north London). The aim is to organise services in ways that provide the best modern care for patients, including access to research trials and new technology and treatments, from good quality buildings and facilities.

The Watford General Hospital campus has now been confirmed as the preferred option for the site of the new Mount Vernon Cancer Centre. The Watford site was the only one to meet all the requirements of the clinical review that was undertaken in 2019.

On 9<sup>th</sup> September an Expression of Interest was submitted to the New Hospitals Programme (NHP) with a decision about who makes the long list expected in late-Autumn.

We have been involved in the scoring and moderation of all the possible options for the Mount Vernon Cancer Centre (do nothing, do minimum, reprovision at Watford - preferred, basic and enhanced - and dispersal) for the pre-consultation business case.

The Patient Reference Group which has been set up to review the NHS England/Improvement patient engagement activity and feedback has been meeting regularly and provided feedback to the Programme Board.

#### Audit of dental practice websites and their NHS entries in Hertfordshire

To audit the dental and NHS websites to evidence whether dental practices are adhering to the NHS England 'Expectations' letter sent January 2021, and to identify any improvements that can be made to the patient experience in accessing NHS dental services.

The report has been published on our website. The Herts Local Dental Committee provided a statement and supported with factual accuracy.

# Public Health East of England Dental Community Dentistry Needs Assessment

We shared relevant contacts with Public Health East of England for their focus groups and reviewed the questions that they would be asking participants.

#### Enter and View visits

These are currently on hold due to the pandemic and the restrictions on face to face activity and visiting in general.

We continued our regular newsletter communication with volunteers, including updates/outcomes from projects they worked on - plus information about volunteer opportunities with partners.

We also advertised, interviewed, and recruited five new Trustees for the Board. Additionally we invited volunteers to save the date for our long-postponed Equality & Diversity Training, now to be held online.

#### 4. Holding commissioners and providers to account and partnership working

Please note, as would be expected, meetings continued to take place via Zoom or MS Teams during the quarter and there was an surprising focus on the pressures faced by the NHS and Social Care in the period and the impacts on patient care. The meetings allow an important opportunity to raise issues from our research and signposting and the NHS and Herts County Council have been very receptive to feedback and how their services can be improved. The section also highlights some new approaches being implemented focusing on equalities and patient and community involvement.

It is worth noting that the demands on services are unsurprisingly a theme discussed at all meetings. Demand for services is consistently high across the system and our role is to ensure that demand management reflects patient needs and safety.

Hertfordshire and West Essex Integrated Care System - Our regular meeting with the Chair and the Joint Chief Executive Officer Herts & West Essex Integrated Care System & Clinical Commissioning Groups provided an opportunity for the strategic challenges for the Integrated Care System to be discussed, and feedback from ourselves about areas of concerns raised by patients and services users. Items included: the significant transformational and transitional work preparing for and implementing changes to the NHS structures and approaches, population health management, inequalities issues, vaccinations, system pressures, and the challenges around mental health, dentistry and access to primary care being experienced.

In the quarter we were also able to be engaged more fully in the Integrated Care System Inequalities workstream and presented at their meeting in the quarter. We were invited to join the group. Additionally, we presented to the System-wide Hospice Chief Executives Group who now wish to work more closely with Healthwatch Hertfordshire. As well as this, we had a meeting with the Director of Primary Care with our colleagues in Healthwatch Essex to talk about how patient engagement across primary care could be effective at the System level.

We were approached by the project lead of the Outpatient Transformation Programme to discuss how to involve patients and the public in this work. This coincided with comments from the East and North Clinical Commissioning Group patient representatives in the Patient Network Quality group who felt there was little engagement with the Integrated Care System. We were able to provide information and contacts to start the process.

Joint meeting Herts Valleys Clinical Commissioning Group and East and North Herts Clinical Commissioning Group - We held our second joint meeting with the Chairs and Managing Directors of the Clinical Commissioning Groups. The meeting focused on shared concerns across the county and included demands on the system generally as well as those specifically on primary care, mental health and paediatric services. In relation to these, our discussion explored how patient use of different pathways could be beneficial for both patients and the NHS. 23.11.2021



#### Contract Monitoring Projects & Activity Qtr 2 (July - September 2021)

<u>Herts Valleys Clinical Commissioning Group</u> - As previously mentioned, we have instituted monthly meetings at the request of the Managing Director of the Clinical Commissioning Group to look at important issues, pressures and challenges, and service performance from a patient and commissioning perspective. Issues covered in recent meetings include demand on services generally including: access to primary care, pressures at Herts Partnership University Foundation Trust and West Herts Hospitals Trust, redevelopment at the Trust, and interface between different NHS services. We also met with the Public Engagement Manager at the Clinical Commissioning Group to explore work around patient engagement linked to coproduction and the South and West Herts Health Care Partnership.

<u>East and North Herts Clinical Commissioning Group</u> - We have regular meetings with the new Associate Director - Quality Improvement at the Clinical Commissioning Group. The meeting looks at how they use Healthwatch information and research to help assess provider performance. It has also covered important themes raised through signposting such as vaccination and access to GPs, as well as discussing system pressures and the current challenges faced.

<u>South and West Herts Health and Care Partnership Quality and Clinical Group</u> - We are now regularly attending this group with a focus on ensuring the development of an effective a model of patient and community involvement as the Partnership develops.

<u>East and North Herts Health and Care Partnership Board</u> - We are members of the Integrated Partnership Board, leading on patient participation, and as such we regularly attend the monthly Board meetings. As mentioned previously, we have worked with partners across the system to develop a model of effective patient involvement across the area. This will include the new Community Assembly chaired by Healthwatch Hertfordshire, which held its first meeting in late-September (covered below in relation to partner activities). We are also involved with the Board's group looking at health inequalities to complement the data around Population Health Management with findings from our research and engagement with ethnically diverse communities.

<u>East and North Hertfordshire Hospitals Trust</u> - During the quarter we had our meeting with the Chair and Chief Executive. The meeting provided updates on pressures on Accident and Emergency services and on the Trust generally, including current numbers of patients with Covid. We also covered how waiting lists are being risk managed (a regular issue we raised with providers). Additionally, we discussed inequalities and engagement issues across the wider Health and Care Partnership.

<u>West Hertfordshire Hospitals Trust</u> - At our regular meeting with the Director of Nursing, the challenges on the Trust of significant demand on services were covered. The success of the virtual hospital approach was discussed and seen as a good model for the future. The meeting also enabled us to raise some issues from signposting including communications with patient's families and interface between different departments at the Trust.

As well as this, we have continued our involvement in Trust Development forums, our joint chairing of the Trust's Co-production Board and also explored with the Deputy Director of Nursing how a consistent model of patient engagement can be embedded across the Trust.

<u>The Princess Alexandra Hospital NHS Trust</u> - During the quarter, we held our meeting with the Director of Strategy and Estates at the Trust. The meeting explored: the plans for the new hospital, and recent developments, digital development at the Trust, and the recent visit by the



Care Quality Commission - including their positive messages about patient involvement at the Trust.

<u>Hertfordshire Partnership University Foundation Trust (HPFT)</u> - Our regular meeting with the Trust Board members was complemented by a meeting with the new Director of Nursing. The huge demand on services is a significant concern with both more service users needing help and a greater acuity of those needing help. Access to services was raised with the Trust, particularly with the demand pressures outlined in the Niche report. We held separate meetings with clinicians to look at access to psychological therapy services and with senior managers to address the actions following our co-production work around support for carers (see section 3). This work was also explored when we presented to the Trust's Carer Council. Our work to inform service users and carers about the new protocol for Dual Diagnosis services has also been complimented by the Trust.

<u>Hertfordshire Community Trust</u> - Our recent meetings with the Chair & Chief Executive and the Director of Nursing took place outside the period of this report.

<u>Central London Community Health Services NHS Trust</u> - We met with the Divisional Director of Nursing and Therapy and items discussed included: pressures on services, plans for winter pressures and vaccination, service transformation (for example of neurology and respiratory services), and restarting of proposals for patient engagement that have been delayed by the pandemic.

<u>Connect Health</u> - We presented at the national Connect Health Change workshop event in July on our work with ethnically diverse communities as part of its programme addressing health inequalities '*Cultural Communities and Health Inequalities*'. The quarter also saw the first of our regular meetings with the provider to explore signposting issues and service developments. This included signposting feedback about telephone handling delays and the measures being taken to address this. Connect Health is keen to collaborate with us to ensure they hear more about patient experiences of services.

Hertfordshire County Council (HCC) - Social Care - Our regular meeting with the Assistant Director for Health Integration covered a number of strategic issues and provided the opportunity to ensure that the importance of Social Care involvement with the Community Assembly was highlighted. As a follow up to the meeting, a number of issues were raised from signposting including social worker cover, care home visitation, and home care visits. We also met with the service users and staff involved with the Connected Lives Gateway project, which has been restarted after lockdown.

<u>Hertfordshire County Council (HCC) - Children and Young People's Services</u> - During the quarter we held two meetings around children and young people's services, partly as an opportunity to meet with the service's new Director. The issues explored included: concerns about the impact of the pandemic on issues such as reduced access to paediatric speech therapy, adolescent mental health, and children looked after (including foster care).

<u>Hertfordshire County Council (HCC) - Scrutiny</u> - During the quarter we presented at the induction event for the new Overview and Scrutiny Committee about the role of Healthwatch and how our approach complements the holding to account role of the committee. We also held the regular meeting between our Chair and the Chairmen of the Scrutiny Committees, where future



scrutiny work on GP access and NHS challenges generally were covered. We have liaised with Scrutiny staff about our contribution to the 'BAME' recovery scrutiny.

<u>Hertfordshire County Council (HCC) - Public Health</u> - Our recent meetings with the Director and the Executive Member were postponed because of annual leave.

<u>Healthwatch England</u> - We chair the Regional Network meeting of Healthwatch and held the regional meeting virtually in August. Our major item was a detailed look at the role of Healthwatch at a time of huge pressures within health and care and how we can make an impact in challenging times. We have also been involved with Healthwatch work nationally on relationships with Integrated Care Systems.

<u>Care Quality Commission (CQC)</u> - We provided intelligence to the Commission following a request for information on home care and mental health provision.

<u>NHS England and NHS improvement End of Life and Palliative Care</u> - We met with the regional leads for End of Life and Palliative Care to develop an involvement model for Local Healthwatch across the region.

<u>University of East Anglia Carer Support Nurse Research Project</u> - The value of having a specialist carer support nurse within the area is being explored, and we met with the research lead to discuss the benefits of the approach and how it might work.

<u>Voluntary and Community Sector partners and Local Councils</u> - As mentioned previously, our relationship with Voluntary and Community Sector partners and District Councils has been further enhanced with partnership opportunities over the last year. A recent example of this is the Stevenage Equalities Commission which held its inaugural meeting in late-September, and we were asked to present on our work with ethnically diverse communities.

The enhanced partnership working is also highlighted through our co-production work with West Herts Hospitals Trust, where we have helped build the relationship between the voluntary sector and the Trust.

We additionally had the opportunity to work closely with the CDA (Community Development Action) Herts, where we are working together on addressing inequalities (see section 3).

Our work to build partnerships in the quarter has also included meetings with:

- Herts Hearing Awareness Service
- North Herts and Stevenage Council for Voluntary Service
- Carers in Herts
- Maternity Voices
- Marie Curie

Further, we have continued to be in contact with Age UK regarding our shared premises and short- and long-term ways of working.

As well as this, the period has seen a rise in the number of requests from patient groups who wish to raise the importance of retaining strong patient involvement when the changes to NHS structures come to fruition.

#### Contract Monitoring Projects & Activity Qtr 2 (July - September 2021)

The number of groups we have been asked to be involved with has increased partly due to the transition from the Clinical Commissioning Groups to the Herts and West Essex Integrated Care System, and partly due the increase in new groups tackling health inequalities. We are reviewing our membership on a regular basis to ensure that volunteer and staff resource is being used effectively.

We continue to meet bi-weekly with NHS England/Improvement Regional dental leads and local Healthwatch; a similar group has now been set up to meet with the East of England Ambulance Service on a bi-monthly basis.

#### Holding to Account Log

We continue to maintain a Holding to Account Log and Changes to Local Delivery Monitoring Log and have regular 'holding to account' reviews of the latest concerns and information and feedback from signposting and surveys. There is also a separate COVID-19 Vaccine log.

As before, many of the themes echo the key themes that Healthwatch England is monitoring such as access to GPs, access to dentistry, and long waits for surgery.
